**Dr. Bernd Otto Hallier** is Managing Director of EHI Retail Institute and President of the European Retail Academy. Dr. Bernd Otto Hallier studied Economics at Hamburg University (Master Degree) and got an external PhD-Degree in 1983 in Hamburg for his analysis of the technology-influence on retail and wholesale. He started his professional career in the tobacco-industry (sales manager, key account manager, assistant to the Board), before he became Managing Director of Retail Institute for Self-Service. Dr. Bernd Otto Hallier founded the German Trade Institute in 1988 and the European Trade Institute in 1993. He is Chairman of the Board of EuroShop and founder of Orgainvent (Tracking and Tracing of cows and beef) and of EUREPGAP/now GlobalGAP (Good Agricultural Practice) as well as Founder of the European Retail Academy. Dr. Bernd Otto Hallier was honoured from Prague-University for the international transfer of know-how between universities of East and West-Europe and became Honorary Professor of the Moscow Government as well Honorary Doctor of Yekaterinburg University.



Dr. Cameron Sawyer is Chairman of the Board of Directors at GVA Sawyer in Moscow. After he earned his Juris Doctor at University of Michigan Law School in 1986 and his B.S. magna cum laude at Vanderbilt University in 1982 Cameron Sawyer was a Deutscher Akademischer Austauschdienst (German Academic Exchange Service) Fellow on the Faculty of Law at Ludwigs-Maximillian-University of Munich, Germany, in 1984-1985. In 1987-1991 he was an attorney in the real estate department of Powell, Goldstein, Frazer & Murphy in Atlanta, U.S.A., where he was involved with a variety of major real estate transactions, representing such clients as LaSalle Partners, Industrial Bank of Japan, Chase Manhattan Bank, Carter & Associates, Sports-Town, Inc., etc. He was Deputy General Director for Perestroika Joint Venture in Moscow as well as Director of Leasing & Marketing. Cameron Sawyer is a popular speaker, writer and consultant on the subject of Russian real estate, and has appeared and spoken at a number of international conferences. Cameron Sawyer's articles have appeared in the Estates News, Moscow Times, Moscow Tribune and others. Interviews with Cameron Sawyer have appeared in The Economist, Ekonomika i Zhizn, Kommersant, etc. Cameron Sawyer has appeared five years running as a guest speaker in classes in Real Estate Finance of Professors John Vogel and Bill Poorvu at Harvard Business School.



**Andreas Schiller** is Director/Editor in chief CEE/SEE Russia/CIS of "Property Investor Europe". Starting in 1993, he worked as a freelance journalist mainly about real estate and urban development topics, before he joined the editorial staff of the German real estate magazine "Immobilien Manager", which Andreas managed as Editor in chief from 1997 to 2003. From 2003 to 2007 he was Publisher of "Immobilien Manager". In 2004 he was announced Editor in chief of the yearbook "Europe Real Estate". In 2007 he co-founded "Competence Circle" and acted as CEO till spring 2009. For more than a decade many of his activities were focused on Russia as well as Central and Eastern Europe. This includes publishing as well as organizing and moderating panels, conferences and business tours about current city development and real estate investment topics in CIS/CEE, either here or there.
